PROGRAM OVERVIEW

- Objective: engage with individuals leaving custody, and connect them with resources and services
 - Connection to existing services in the community – treatment, housing, employment, and more
 - Direct support: court reminders & justice system navigation
 - Resources: transportation, cell phones
- Metrics for success: increased court appearance, lower rearrest
- Staffed with Justice Navigators, each who have lived experience



LOCATION





POPULATION SERVED

- Initial target population: people who were released by Pretrial Services before jail booking
- Added: individuals booked into the jail, and released at IA hearing
- Available to help anyone released
- However...
 - Anyone who walks in the door can get help, no one is turned away





- Almost 500 encounters in 6 months of operation (August 3, 2023 to February 3, 2024)
 - 416 unique individuals
- Of those that walk into the door
 - 97% accept some form of assistance
 - 57% identified as homeless
 - Average age of 39

- 54 individuals received a CALL phone
- 53 were transported CARS taxi program
- Over 100 people were referred to substance use treatment services
- 90% of individuals served through the Transition Center were not rebooked within 30 days
 - Baseline 73% were not rebooked
